Subject: Participation in **Mukhiya Mantri Vigyan Pratibha Pariksha (MVPP) 2025**

Dear Students,

This is to inform all students of **Class IX** inform that the **Mukhiya Mantri Vigyan Pratibha Pariksha (MVPP) 2025** will be conducted by the **Directorate of Education, GNCT of Delhi** on **16th November 2025 (Sunday) [Tentative]** at various DOE schools in Delhi.

The objective of this examination is to identify and nurture talented students. Students securing top ranks (category-wise) will be awarded a **one-time scholarship of Rs. 5000/-** along with a **Merit Certificate**.

Eligibility:

1. Students currently enrolled in **Class IX** in Govt., Govt. Aided, Unaided recognized private schools, including KVs, JNVs, NDMC, DCB schools in Delhi.
2. Students must have secured minimum **60% marks in Class VIII** (General/OBC) or **55% marks** (SC/ST/PH) in the session 2024-25.

Reservation: As per GNCT Delhi norms (SC/ST/OBC/EWS/PH).

Examination Pattern:

- **Paper-I:** Mental Ability Test (MAT) – 100 Questions, 100 Marks, 100 Minutes
- **Paper-II:** Scholastic Aptitude Test (SAT) – 100 Questions, 100 Marks, 100 Minutes
- **No negative marking.**

Selection:

- Qualifying Marks: 32% (SC/ST/PH) & 40% (General/OBC/EWS) in both tests.
- Merit-wise selection category-wise for scholarship.

Application Process:

1. Students are to be registered by the **Head of School** through the DOE website: www.edudel.nic.in from **11/09/2025 to 04/10/2025**.
2. Admit cards will be issued to students by the school on or before **15th November 2025 [Tentative]**.

Important Instructions for Students:

- Ensure your **EWS/OBC/SC/ST/PH certificate** is valid and submitted to the school (if applicable).
- Provide your **own bank account details** for scholarship; parent accounts are not valid.
- Double-check your **category** before registration as no changes will be allowed after result declaration.

All interested and eligible students of Class IX are requested to submit their consent along with necessary certificates to the **school office by 20/09/2025**.
